## 2026 ICSI BREEDING SERVICE CONTRACT

1. I, \_\_\_\_\_ (Mare Owner), hereby reserve one breeding to "Spooks N Jewels" AQHA #5579427 for the Mare \_\_\_\_\_, Reg. # \_\_\_\_\_ for the Breeding Fee of **\$1,500** plus the Booking Fee of **\$500** (at contract signing). A separate contract is required for each additional embryo produced via ICSI procedure. Fappani Performance Horses, Inc. is to be notified of the number of embryos produced as soon as the ICSI procedure is completed. At that time, a contract for each additional embryo produced will be needed. Additional Embryo Fees are as follows: Breeding Fee of **\$1,500** each (contract and all fees are due when recipient mare has a 45-day positive pregnancy check). FROZEN EMBRYOS WILL BE CHARGED BREED FEE FOR THE YEAR THEY ARE UTILIZED AND FAPPANI PERFORMANCE HORSES, INC. NOTIFIED OF THE YEAR UTILIZED. Breed Fee and Office Fee will be due at 45-day positive pregnancy check.
2. Please state what ICSI Facility will be used: \_\_\_\_\_
3. Owner must attach a copy of the Mare's registration papers to this agreement. Owner agrees to breed the mare specified.
4. Mare shall be bred using an Intracytoplasmic sperm injection ("ICSI") procedure into the cytoplasm of a mature oocyte, which physically causes fertilization. Mare Owner may choose to work with any approved facility to have their mare's oocytes injected. Please contact our office for approved facilities.
5. Frozen semen will be used for this contract unless fresh semen is available AND requested. Shipped semen fees may apply.
6. This contract provides for one (1) Breeder's Certificate. If multiple embryos are retrieved from one breeding, it will be the responsibility of the Mare Owner to notify Fappani Performance Horses, Inc. of number transferred.

7. Stallion Breeding Reports are prepared immediately after the end of breeding season. If not reported by November 15<sup>th</sup>, mare owner will be responsible for all late fees. It is the Mare Owner's responsibility to notify Fappani Performance Horses, Inc. when any Frozen Embryos are utilized, and complete contract for the breed fee of the year utilized.
8. TO OBTAIN A "BREEDERS CERTIFICATE" YOU MUST NOTIFY FAPPANI PERFORMANCE HORSES, INC. OF THE BIRTH OF THE FOAL. CERTIFICATE WILL NOT BE ISSUED IF THE ACCOUNT HAS NOT BEEN PAID IN FULL.
9. If it should become necessary for Fappani Performance Horses, Inc. to retain the services of an attorney to enforce it's rights under the terms of this contract, including but not limited to the collection of any sums due, the Owner will pay Fappani Performance Horses, Inc. all expenses and costs, including reasonable and necessary attorney's fees incurred by Fappani Performance Horses, Inc. in enforcing this contract.
10. Any dispute related to this contract will be governed by the laws of the State of Arizona and venue of any dispute arising from this Contract shall be in Maricopa County, Arizona.
11. This Contract is non-transferable nor assignable without prior written consent from Fappani Performance Horses, Inc..
12. All International and Us Clients must pay with US Funds via Credit Card (3.5% Surcharge for MC, VISA, DISCOVER or AmEx) Wire Transfer (\$50 Surcharge) or check from a US Bank account.
